

## RE: APOSTLE ANSELM MADUBUKO'S "INTERVENTION" IN THE MERCY CHINWO, JUDIKAY AND EZEKIEL THANKGOD (EeZee Tee) MATTER

This is a response to Apostle Anselm Madubuko's Press Statement dated and publicized on the 18th of January, 2024.

I am not surprised at the statement made by the Apostle, I expected it and still expect more to come from others within the gospel and church ecosystem..

It is important that when Men of God who hold positions of influence over followers are entrusted with the responsibility to resolve conflicts, they do it without bias and with a sense of fairness that God teaches us to uphold.

At the first mediation meeting called by the Apostle, the Label expressed that one of the artistes had been boycotting scheduled events for higher-paying engagements and diverting funds into her personal account, contrary to the terms of her contract.

The Apostle remained silent and refused to address the breaches alleged against the said artiste. At a second meeting, which had Efe Omoregbe, Mama Hilda Dokubo, Mr Mena, the artistes' husbands (both serve as their managers), as the artistes were absent. The focus of the mediation centered around the catalog, with the artists demanding the transfer of master rights to them. However, this is not possible as they are only entitled to royalties from it.

After it was obvious that we would not cower into relinquishing the master rights, the conversation fleetingly shifted to a discourse about auditing. We all agreed to appoint an independent unbiased auditor that will audit the Label's account and Mercy Chinwo's accounts to establish who indeed was being financially untruthful. However, on our part, we still went on to submit all our books to Judi Kay's personal auditors to commence the auditing process.

Let me start by stating unequivocally that even though they have tried very hard to make the allegations against the Label that of diversion of funds and mismanagement of Royalties, IT IS NOT SO, NO FUNDS WERE DIVERTED BY EEZEE CONCEPT. The singular motive is to find a way to forcefully claim ownership of the Music Catalogue that was created during the term of her Agreement with the Label against the clear expression of the Agreement that the Company owns the Catalogue in perpetuity and will only account to her for Royalties.

Contrary to the assertion made by the Apostle, he was indeed the one that stopped picking my calls or replying to my messages after I kept following up about rescheduling a meeting to appoint new auditors trusted by all parties.

I called the Apostle several times, messaged him and even went physically to his house TWICE to ensure that this matter was amicably resolved. I kept reminding him of the meeting he promised to convene and his response to me was that I should relax that he would let me know when a date for the meeting is fixed. Up till date, I did not get a word.

All that the Apostle kept telling me was that he would revert when he had word from the other parties. While I was running helter skelter to resolve the is it e, it became apparent something unimaginable was at play as I got detained in Ilorin for 9 days. During this period, ALL my records and books of account were investigated and NO wrongdoing was discovered on the path of Eezee Concept. I was denied access to my family; my wife and child. I could not access my accounts as all my personal and corporate accounts were frozen during this period. My international passport suspiciously got missing this period too. Only God understands what I went through.

All I did was invest in Christian creatives and make an attempt to build the gospel music ecosystem further.

Throughout the contract period, Eezee Concept provided periodic financial reports to all its talents, allowing them to seek clarification or contest any discrepancies.

It is very disheartening and sad to see that people who God has called to lead his Flock will deliberately seek to pervert the course of Justice and employ their hallowed position to make false claims and misrepresent facts of an issue. Our God is a God of Justice and He Will mete out his wrath on the party that is being dishonest in this matter.

Despite the challenges, Eezee Concept remains committed to pursuing a fair and unbiased resolution to uphold justice and maintain the integrity of our contracts and our organization.
